**NOTICE IS HEREBY GIVEN** that on Wednesday, June 17, 2020, at 7:00 p.m. (or as soon thereafter as possible) the City Council of the City of Aliso Viejo will consider the following public hearing item:

**APPROVE THE FY2019-2020 ANNUAL ACTION PLAN SUBSTANTIAL AMENDMENT FOR THE PROPOSED USE OF COMMUNITY DEVELOPMENT BLOCK GRANT - CORONAVIRUS (CDBG-CV) FUNDS**

**Hearing Location:** City Hall Council Chambers, 12 Journey, Suite 150, Aliso Viejo, CA 92656 (Unless otherwise noted in the advisory below.)

In accordance with federal regulations [24 CFR 91], and applicable waivers made available through the Coronavirus Aid, Relief, and Economic Security Act of 2020 (CARES Act), notice is given that the City of Aliso Viejo is making amendments to the its Citizen Participation Plan and the 2018-2022 Consolidated Plan/2019-2020 Annual Action Plan.

**Amendments**

The City's Citizen Participation Plan (CPP) outlines the actions the City takes to encourage public participation in the CDBG program planning process, including amending CDBG-related plans. The U.S. Department of Housing and Urban Development (HUD) has advised the City to amend the CPP to include disaster/emergency procedures, and incorporate program waivers issued on March 31, 2020. The CPP has been amended to allow for a five-day public comment period, and virtual public hearings deemed necessary to protect public health from the transmission of the Coronavirus.

The 2018-2022 Consolidated Plan/2019-2020 Annual Action Plan Substantial Amendment will enable the City of Aliso Viejo to receive and administer \$129,348 in Community Development Block Grant - Coronavirus (CDBG-CV) funding allocated to the City by HUD. The amendment will add CDBG-CV funds to the 2019-2020 Action Plan for following activities:
